This edition of the Beacon is intended to be special for many reasons. We have had some long serving (can also be read as long suffering :) members of our Leadership Team. I have been your Pastor for five full years and two of our departing members have been on the LT since I came.

Linda Greenfield was in the position of Stewardship Rep to the LT. She was on the LT before I arrived. She agreed to stay on to help with the transition to a new Pastor and to provide institutional memory for the Team. I had no worries about her ability to be our memory once I saw Linda in action. Bill has been the member who wrangles the Endowment Team dealings and decisions. If there was ever a position I hold in high esteem, it's the folks that deal with investments. It is a dangerous spot to be in. Churches are especially cautious with their investments and rather possessive. After all, it is the one spot of ultimate trust, to take money people didn't NEED to give to the church but did anyway. Use of those funds is a large responsibility. To Bill's credit, he has had an eagle eye on the Financial Resolution which guides the use of ET monies. There have been times when he has winced at some suggestions for ET funds, and has been compassionate, yet diligent, at turning those suggestions away. He has been very faithful to keeping with the wishes of the church when the FR was established. Not all churches have a person who can say no and be thanked for that answer. We've had interactions with the City Council about taxes for the Buckley Pass issue. We've considered and passed a policy for adopting an Anti-Racism. We have navigated installing a Hearing Loop system. We have upgraded our technology several times. We have added the Social Justice Ministry Team to our church. The largest challenge has been adjusting to the world of Covid-19 and how that effects everything we do. Bill is not done though. He has agreed to take on the responsibility of Assistant Clerk. So, his institutional memory will remain on the LT too.

I have had a wonderful Leadership Team ever since I arrived. It has been a joy and relief to have so many gifted leaders take our church through its life. It is certainly a new experience for me :)
